Clicking on the event number will open the following screen which gives details like RFx number, submission deadline date and time, remaining time for submission of response (offer). It also shows the RFx version number.




Prior to submitting a response (offer), vendor can see the print preview of the RFx


From the above screen shot the attached file is visible. In case a file has been attached by mistake then the same can be deleted by checking the file row and clicking on delete button. The file will get deleted.

1. INTRODUCTION

Steel Authority of India Limited (SAIL) is one of the largest steel-making company in India and one of the Maharatna of the country's Central Public Sector Enterprises. The details about the Company, its entire product range and operations are available at the Company's website: www.sail.co.in.

A TMT Bar Mill with an annual capacity of 100000 TPA was installed by SAIL DSP at Steel Processing Unit (SPU) Kandrori, Dist –Kangra, HP, Pin no- 176402, to produce TMT bars of diameter 8 to 25 mm in straight lengths from cold concast billets of size 125*125*3000 mm. Sizes of the bars are 8, 10, 12 mm diameter TMT (to be produced in regular basis) and 16, 20, 25 mm diameter (to be produced as per requirement); and grades of the bars to be produced are TMT 500D /550D /SeQr /600 for all sizes.

Structure and the manner of O&M shall be detailed in the final Tender Document(s), to be published later on.

The sole objective of this IM is to solicit Expression of Interest (EOI) from Interested Parties for taking part in Revamping, Technological modification (if any as per requirement) and O&M of TMT bar Mill of SAIL at SPU Kandrori through Total Outsourcing Business Partner (TOBP) basis.

2. OBJECTIVE

The objective of this Information Memorandum (IM) is to solicit EOI from parties, who satisfy the eligibility criteria set out in this IM, for Revamping, Operation and Maintenance (O&M) with Technological modification (if any as per requirement) on contract (TOBP) basis in that existing 100,000 TPA TMT bar mill at SPU Kandrori of SAIL to produce the Lower diameter TMT bars, viz. 8mm to 12mm in regular basis, and, also, 16mm to 25m TMT bars as per requirement. Grades of TMT bars should be TMT 500D /550D /SeQr /600 for all sizes.

SAIL DSP intends to explore the modalities of Revamping, Operation and Maintenance (O&M) of the TMT bar Mill with Technological modification (if any as per requirement) on contract basis (TOBP) in the existing 100,000 TPA TMT bar mill at SPU Kandrori of SAIL to produce the Lower diameter TMT bar (8mm to 12mm) in regular basis and 16mm to 25m TMT (as per requirement) of TMT 500D /550D /SeQr /600 grades. The contract period would be 5 years extendable by 1 year at the sole discretion of SAIL-DSP.

The EOI is invited from experienced and capable parties for better understanding the detail component wise requirement for subsequent preparation of Tender Document(s).

SAIL DSP reserves the right to withdraw the EOI or to alter any of its terms and /or the process at any stage without assigning any reason whatsoever. **Please note that no financial quotes shall be submitted in EOI submission.**



3. Eligibility criteria

EOI submission by consortium shall not be allowed. All financial criteria are based on audited statements of accounts for the relevant Financial Year(s) (FY). FY ended March 31, 2023, is henceforth referred to as "last FY".

- A. The party should fulfill following qualifying/ eligibility criteria (EC) to be eligible for participating in the process:
- ➤ Should have experience of managing operation and maintenance of Rolling Mill of minimum 75000 TPA capacities, producing BIS certified 8mm, 10mm & 12mm TMT bars (with or without other sizes of TMT). Production of that mill should be minimum 55000 tons per annum (with 50% production volume of 8mm, 10mm & 12mm TMT cumulatively) during any one of the last three financial year as on date of EOI.
- ➤ In case the mill operation & maintenance is managed by party (irrespective of owning or not), party shall submit the following documents:
 - Factory license
 - Valid BIS certificate for the product (any one of 8mm or 10mm TMT with any one of the grades as mentioned in Objective Clause 2) of that Rolling Mill
 - GST registration certificate
 - Production data for the last three financial years duly certified by CA as per **Annexure-5**
- Further, in case the party is not the owner of the mill, but only manages operation & maintenance of the mill, then the party shall **also** submit the following documents:
 - Copies of contract agreement/ work order with owner of the mill
 - Completion/performance certificate from owner of the mill
- B. Average annual financial Turnover of the party during the last three financial years ending 31st March, 2023 shall be at least Rs 25 Crore (Rupees twenty five crores only). Copies of audited profit & loss account & balance sheet for above three years and turnover certificate to be issued by practicing chartered accountant with UDIN as per the format given at **Annexure-5** shall be submitted as documentary evidence.
- C. The party should have GST registration. Copy of GST registration shall be submitted as documentary evidence.



4. Broad Scope of work

The broad scope of work will be as follows:

- i. SAIL will hand over the TMT bar mill at SPU Kandrori on 'as is where is' basis. All sort of Repairing, revamping, reinstallation etc required to produce the Lower diameter (8mm to 12 mm) TMT bar, have to be done by TOBP by their own investment in the existing 100,000 TPA TMT bar mill at SPU Kandrori.
- ii. Also, any Technological modification (if any as per requirement) required in the existing 100,000 TPA TMT bar mill at SPU Kandrori of SAIL, to produce the Lower diameter (8mm to 12 mm) TMT bar, may be done by TOBP by their own investment. For this type of Technological modification (if any as per requirement), the TOBP will have to deliberate the same to SAIL and prior permission will have to be taken from SAIL by submitting the details of the job.
- iii. All these Revamping jobs and Technological modification jobs (if any) should be done aiming to produce minimum 40,000 MT of 8mm, 30000 MT of 10mm & 5000 MT of 12mm TMT bars against the supply of required sufficient quantity of billets. For any short supply of billets, production of 8mm, 10mm & 12mm TMT bar should be done in pro rata basis.
- iv. The balance quantity of production will be done in 8mm/10mm/12mm TMT (with mutual discussion). However, in case of any market requirement, mill must be able to produce any or all of 16mm, 20mm, 25mm TMT bars.
- v. Also, all the Revamping jobs and Technological modification jobs (if any) may be done aiming to produce TMT Quality/Grade of FE 500 D/FE 550 D/FE 600/SAIL SeQR 550D/500D or/and as specified by SAIL in conformity with BIS. Fe 550D will be the base grade of production. SAIL SeQR 550D grade TMT bars are having UTS/YS ratio 1.15 (min.) & elongation 16% (min.); and, SAIL SeQR 500D grade TMT bars are having UTS/YS ratio 1.16 (min.) & elongation 18% (min.).
- vi. The scope of the work inter-alia will include the complete operation and maintenance of the facilities within the technical limits of receiving input materials and delivering finished product. The O&M will be done on Total Outsourcing Business Partner (TOBP) Concept.
 - Normally, transportation of billets to input delivery points and finished products from product delivery points shall be done by SAIL, however, TOBP may also be asked for transportation as per SAIL transportation rate.
- vii. TOBP will operate and maintain the facilities after the Revamping and Technological modification jobs (if any) at the site by making its own investment, in conformance with the technical specifications and battery limits. TOBP will be entitled to receive the service charges from SAIL on per tonne basis.



viii. The tentative details of Input materials to be supplied by SAIL is placed below:

Quantity : 104,800 TPA

Duration of the contract : 5 years; plus extendable by 1 year at the sole

discretion of SAIL.

Billets supplied by SAIL : 125mm x 125mm x 12000/ 9000 mm

The tentative detail of desired Finished Products to be produced by TOBP is placed below:

Desired production : 1,00,000 MT. Min. Desired production : 75,000 MT

Product Mix : 8mm to 12 mm TMT bars (primarily) and 16mm

to 25mm TMT (as per requirement)

The tentative product mix for minimum desired production is as below:

8mm - 40,000 MT 10mm - 30,000 MT 12mm - 5,000 MT

Or, in pro rata basis, in case of short supply below 78, 500 MT of billets For production of more than minimum desired production, i.e. more than 75,000 MT, balance quantity can be made up by either one or two or all of 8mm, 10mm and 12mm TMT.

However, beyond minimum desired production 16 to 25 mm TMT may be produced, if demanded by SAIL.

Quality: FE 500 D/FE 550 D/FE 600/ SAIL SeQR or/and as specified by SAIL in conformity with BIS. Fe 550D will be the base grade of production. SAIL SeQR 550D grade TMT bars are having UTS/YS ratio 1.15 (min.) & elongation 16% (min.); and, SAIL SeQR 500D grade TMT bars are having UTS/YS ratio 1.16 (min.) & elongation 18% (min.).

<u>Yield</u> (Billet to finished products) should be 95.5% (min.), out of which 91.0% (min.) should be of standard length (12m normally) and rest 4.5 % (max.) should be stock length (mix of 6m to <12m).

Requirement of **SAIL SeQR** brand may go up to approx 70% of the total requirement.

- ix. Process scrap and mill scale generated during TMT bar production will be SAIL property and disposed of by SAIL. All support services have to be provided by TOBP.
- x. TOBP have to prepare and submit Standard Operating Procedure (SOP) & Standard Maintenance Procedure (SMP) within 15 days of issuance of WO (Work Order) and compliance of same to be submitted on monthly basis. Compliance of same will be decided by SAIL.



- xi. TOBP has to deploy required number of Technical experts, Supervisors, Technicians, Skilled, Semi skilled and Unskilled manpower as per required skill set for judiciously operating the facilities of TMT Bar Mill.
- xii. List of Insurance spares are to be listed out by TOBP and the modalities of spare maintenance is to prepared and submitted to SAIL.
- xiii. Data entry by TOBP at SAP in real time basis will be mandatory for stock reconciliation.
- xiv. Statutory compliance, safety of man, machine and material, proper housekeeping, internal transportation etc have to be ensured by TOBP.
- xv. TOBP has to strictly implement and follow the latest Safety Guidelines of Ministry of Steel (MOS) in the entire complex of SPU Kandrori TMT Bar Mill. TOBP need to deploy whole time basis Safety Supervisor/ Engineer at the shop-floor.
- xvi. Any other requirement for proper O&M of the facilities will be in TOBP's scope.
- xvii. The cost of Revamping, Technological modification (if any as per requirement) of facilities and Operation & Maintenance for desired production to be borne by TOBP as per the service charge quoted on per tonne basis.



5. Brief process

Based on evaluation of EOI received, the subsequent bidding process will be formulated. Hence, it is necessary that all the interested organizations, submitting EOI, should have experience of doing such type of jobs with expert/skilled human resources.

During the initial process, all interested parties, before submission of EOI, will be provided with an opportunity to:

- Study/Understand the existing facilities, boundary limits, local conditions, existing procedure, past performance, limitations, shared etc at the TMT bar Mill installed in Mill complex at SPU Kandrori.
- Undertake site visits to collect relevant information of the site and carry out technical assessment for revamping work, as well as, Operation & maintenance of the Mill and required modification, if any.
- Hold discussions with SAIL DSP, if required
- Presentation by shortlisted parties.

All parties will also be furnished with further information, if required. However, information will be provided at the sole discretion of SAIL.

The terms relating to submission of bids will be set out in the Tender document(s) to be prepared for the purpose.

However, this IM along with its enclosures, constitute no form of commitment on the part of SAIL, whether in respect of the appointment of TOBP process or otherwise. Furthermore, this invitation confers neither any right nor expectation to any party to participate in the Operation and Maintenance and modification process, if any, of TMT bar Mill at SPU Kandrori.
